At the beginning of this term, the Senate began a formal system of resolutions to record key decisions and contribute to institutional memory. Together with meeting minutes, these resolutions record formal Senate actions and positions on a variety of topics relating to undergraduate life, campus issues, and Senate operations. Examples of such resolutions include expressions of support or opposition to University policies or proposals, confirmation of nominees to committees, approval of the Senate semester budget and other funding requests, adoption of procedural rules, creation of ad hoc committees, amendment of documents, and expressions of appreciation and thanks to campus partners and other individuals and organizations.

(2) SENATE DISCUSSION.—The Senate shall discuss the candidates and election until the previous question is ordered in accordance with paragraph (3).

(3) ORDERING THE PREVIOUS QUESTION.—

(A) IN GENERAL.—Except as otherwise provided in subparagraph (B), the previous question shall be ordered and the Presiding Officer shall initiate the voting procedure described in subsection (d) only upon a 2/3 vote of the Senate.

(B) NO FURTHER DISCUSSION.—If there is no further discussion, the previous question shall be considered ordered and the Presiding Officer shall initiate the voting procedure described in subsection (d).

(d) VOTING.—

(1) SECRET BALLOT.—Voting as described in this subsection shall be by secret ballot.

(2) CANDIDATES WHO ARE INCUMBENT VOTING SENATE MEMBERS MAY VOTE.—Each candidate who is also an incumbent voting Senate member may vote as described in this subsection.

(2) TIME LIMIT FOR PUBLIC COMMENT PERIOD; SENATE MAY EXTEND.—The public comment period shall not exceed 60 minutes unless the Senate, by a majority vote, extends the public comment period by a definite amount of time.

(3) TIME LIMIT FOR INDIVIDUAL COMMENT.—An individual may address the Senate for not more than 2 minutes.

(4) YIELDING OF TIME.—An individual may not yield time to another individual.

(5) MULTIPLE COMMENT.—After addressing the Senate, an individual may not address the Senate again until each other individual who wishes to address the Senate has done so.

(d) RESPONSE TO PUBLIC COMMENT.—

(1) SENATE SHALL WITHHOLD COMMENT.—Except as otherwise provided in paragraph (2), each Senate member shall not respond to any public comment until the agenda item during which the Senate shall consider its position relating to the proposed changes to University sexual misconduct policies.

(2) CLARIFYING ISSUES OF FACT.—The Presiding Officer may recognize a Senate member or the Vice Provost for Institutional Equity and Diversity to clarify any issue of fact that is raised during the public comment period.

Whereas the Office for Civil Rights of the United States Department of Education has been investigating the University for potential violations of Title IX of the Education Amendments of 1972, which prohibits discrimination on the basis of sex in any educational program that receives federal funding;

Whereas an undergraduate—no matter the sex, gender identity, or gender expression of the undergraduate—can face extreme difficulty in accessing all educational opportunities at Princeton if the undergraduate is a victim of sexual misconduct;

Whereas on September 15, 2014, the Faculty approved changes to University procedures for addressing issues relating to sexual misconduct;

Whereas on September 18, 2014, the Executive Committee of the Council of the Princeton University Community (“CPUC”) approved proposed changes to University sexual misconduct policies;

Whereas on October 7, 1968, the Faculty adopted a document relating to the rights and responsibilities of students that reads, in part, as follows:



*Students and the University* (Oct. 7, 1968), reprinted in *Rights, Rules, Responsibilities* § 2.1, para. 3 (2014).

As constituents of the academic community, students are expected, individually and collectively, to express their views on issues of institutional policy and on matters of general interest to the student body;

Whereas the Senate conducted a public hearing on September 21, 2014 to hear the thoughts and insights of undergraduates and other members of the University community relating to the proposed changes to University sexual misconduct policies;

Whereas section 103(4) of the Senate Constitution provides that a key object of the Senate is to “discuss, deliberate, and take an official position on a question relating to or affecting undergraduate life or any other question of interest to undergraduates”; and

Whereas University sexual misconduct policies are of high importance to undergraduates: Now, therefore, be it

#### **SECTION 1. EXPRESSION OF SUPPORT; RESERVATIONS.**

(a) **IN GENERAL; RESERVATIONS.**—The Senate supports the proposed changes to University sexual misconduct policies as approved by the Executive Committee of the CPUC. However, the Senate expresses certain reservations as described in sections 2 and 3.

(b) **CONSIDERATION BY CPUC.**—The Senate urges the CPUC to support the proposed changes to University sexual misconduct policies.

#### **SEC. 2. RESERVATION RELATING TO THE REPORTING REQUIREMENTS FOR RESIDENTIAL COLLEGE ADVISERS.**

(a) **IN GENERAL.**—The Senate is concerned about the possible implications of requiring a Residential College Adviser (“RCA”) to report to the corresponding Director of Student Life if the RCA is made aware of a potential case of sexual misconduct that involves an individual other than an advisee of the RCA.

(b) **ACKNOWLEDGEMENT OF FEDERAL MANDATE; SHARE PROMOTION.**—The Senate acknowledges that the Office for Civil Rights of the United States Department of Education has mandated the new reporting requirement for RCAs as described in subsection (a). Therefore, the Senate urges the University to promote the Sexual Harassment/Assault Advising, Resources, and Education (“SHARE”) Office as the primary resource for any member of the University community, including any advisee of an RCA, who faces or knows of an alleged case of sexual misconduct.

#### **SEC. 3. RESERVATIONS RELATING TO THE PROCEDURAL CHANGES APPROVED BY THE FACULTY.**

(a) **IN GENERAL.**—The Senate expresses the reservations described in subsections (b), (c), and (d) in relation to the changes to University

(B) The adjudicative role to the extent that the panel determines whether a respondent violated University policy.

(2) **SENATE REQUEST FOR ACTION.—**The Senate urges the Faculty-Student Committee on Sexual Misconduct to explore different investigation and adjudication procedures that would not assign the 2 roles described in paragraph (1) to the same entity.

**SEC. 4. VOTING BY U-COUNCILORS.**

This resolution shall not be construed to order the U-Councilors, USG President, or USG Vice President to vote in a particular way on any question that the CPUC considers relating to the proposed changes to University sexual misconduct policies. Nevertheless, the Senate requests that each U-Councilor, the USG President, and the USG Vice President consider the position of the Senate as a whole as described in section 1.

### PROPOSED CHANGES TO UNIVERSITY GRADING POLICY— SENATE POSITION

Princeton University, *Report from the Ad Hoc Committee to Review Policies Regarding Assessment and Grading (2014)* [hereinafter *Report*].

Whereas on October 7, 2013, President Christopher L. Eisgruber established the Ad Hoc Committee to Review Policies Regarding Assessment and Grading (“Committee”) with directions to evaluate current University policies relating to the assessment and grading of student work;

Whereas on August 5, 2014, the Committee released its recommendations in *Report from the Ad Hoc Committee to Review Policies Regarding Assessment and Grading (“Report”)*;

*Report*, § 1.2, at 2-3.

Whereas the Committee makes 4 key recommendations in the *Report*, namely—

- (1) “Remove the numerical targets from the grading policy”;
- (2) “Charge departments with developing their own grading standards”;
- (3) “Dissolve the Committee on Grading”;
- (4) “No changes to freshman year”;

Whereas the Senate and the Senate Academics Committee have expressed concerns relating to the current grading policy, summarized in the *Report* as follows:

(1) “It deters admitted students from matriculating”;

(2) “It may cause students to select departments based upon perceived grading tendencies, and may harm concentrators in small departments or departments in which mostly upper-level courses are offered;”

(3) “It has led to emphasis on the letter grade rather than substantive instructor feedback”;

(4) “It disadvantages Princeton students in the external marketplace, where some employers have GPA cutoffs and are likely to treat Ivy League GPAs as providing similar information”;

Whereas section 103(4) of the Senate Constitution provides that a key object of the Senate is to “discuss, deliberate, and take an official position on a question relating to or affecting undergraduate life or any other question of interest to undergraduates”; and

Whereas University policies relating to the assessment and grading of student work are of high importance to undergraduates: Now, therefore, be it

suggesting that students from institutions with lower average GPAs may face disadvantages when applying to post-undergraduate opportunities.<sup>2</sup>

(B) SENATE REQUEST FOR ACTION.—For the benefit of undergraduates, the Senate calls on the Faculty to further investigate the effect of a lower average GPA.

(2) A+ SHOULD COUNT AS A 4.3.—It is the sense of the Senate that the grade of A+ should count as a 4.3 in the calculation of a grade point average (GPA), as was the case until 2000.

**TITLE I—UNDERGRADUATE EXPERIENCE**

**SEC. 101. ACADEMIC PROGRAM.**

The Senate calls on the faculty to establish—

- (1) the Program in African American Studies, the Program in Latino Studies, the Program in Latin American Studies, and the Program in Gender and Sexuality Studies as formal undergraduate concentrations while maintaining their certificates of proficiency;
- (2) certificate programs in Asian American Studies and Disability Studies; and
- (3) a distribution requirement relating to topics of diversity and culture.

**SEC. 102. DIVERSITY PROGRAMMING DURING ORIENTATION.**

The Senate calls on the administration to expand programming relating to diversity during freshman orientation with input and guidance from undergraduates, the Carl A. Fields Center, the LGBT Center, the Women's Center, and the Office of Disability Services.

**SEC. 103. REPORTING MECHANISMS; PROCESSES.**

The Senate calls on the administration to work with undergraduates to create and institute transparent and accountable—

- (1) reporting mechanisms for issues of discrimination, microaggressions, and bias incidents; and
- (2) processes for investigating, addressing, and adjudicating these issues.

**SEC. 104. CAREER SERVICES PROGRAMMING.**

The Senate calls on Career Services to expand programming for undergraduates from underrepresented backgrounds.

**SEC. 105. DIVERSITY PEERS.**

The Senate calls on the administration to establish a peer educator program—

- (1) to address issues of diversity and inclusion; and
- (2) that is organized similarly to the Sexual Harassment/Assault Advising, Resources, and Education Peer program.

**SEC. 106. FUNDING OF ACTIVITIES.**

The Senate calls on the administration to examine and enhance funding for identity groups.

**TITLE II—FACULTY AND STAFF****SEC. 201. FACULTY DIVERSITY.**

The Senate calls on the administration to—

- (1) improve outreach to prospective faculty members of various identities and backgrounds; and
- (2) hire across all academic departments more faculty members of various identities and backgrounds.

**SEC. 202. CULTURAL COMPETENCY TRAINING.**

The Senate calls on the administration to institute mandatory cultural competency training for all University faculty, staff, adjudicators, preceptors, and teaching assistants.

**SEC. 203. ASSOCIATE DEAN OF UNDERGRADUATE STUDENTS FOR DIVERSITY.**

The Senate calls on the administration to hire an Associate Dean

of Undergraduate Students whose portfolio and duties would be dedicated to topics of equity and diversity among the undergraduates.

**SEC. 204. RESIDENTIAL COLLEGE DIVERSITY STAFF.**

For each residential college, the Senate calls on the administration to hire a staff member whose portfolio and duties would be dedicated to topics of equity and diversity.

**SEC. 301. ANNUAL GIVING AND DONATIONS.**

For Annual Giving and other opportunities to donate, the Senate calls on the Office of Development to allow alumni and other individuals to donate directly to affinity groups and cultural heritage programming.

**SEC. 302. TRANSPARENCY IN DATA.**

The Senate calls on the administration to—

- (1) release disaggregated demographic data relating to undergraduate matriculation, including, without limitation, data for—
  - (A) race and ethnicity;
  - (B) socioeconomic background; and
  - (C) legacy status;
- (2) create and issue a survey with undergraduate input that—
  - (A) collects data that is indicative of the undergraduate experience;
  - (B) ensures a high response rate and a representative sample by rigorous survey design and incentive programs; and
- (3) make the results of the survey described in paragraph (2) publicly accessible.

**SEC. 303. EXAMINING EQUITY AND DIVERSITY GENERALLY.**

The Senate calls on the Council of the Princeton University Community (“CPUC”) and the administration to continue working with undergraduates to examine issues of equity and diversity in the undergraduate experience generally.
